BOARD MONTHLY FINANCIAL REPORT

The financial report was reviewed and accepted.

OCCUPATIONS AND PROFESSIONS REPORT

Ms. Jarboe reported the current events of O&P including the appointment of a new Public Protection Cabinet Secretary, Ambrose Wilson IV, the tobacco and vaping ban for all state properties effective November 20, 2014, the addition of Board Administrator, Jessie Parker, to the Office of Occupations and Professions and a report of the ongoing revisions of the on-line license renewal system.

The Board reviewed and discussed the current draft of the Model List of suicide prevention courses approved by the Cabinet for Health and Family Services.

The Board received correspondence from Adrienne Cenci, and LPCC applicant, regarding whether or not an LPCC is required to be licensed in Kentucky for two years to be eligible to supervise LPCA's. The Board determined that 201 KAR 36:060 section 3(4)(c) requires a supervisor to have been independently licensed for two years but KY licensure for two years is *not* required.

The Board will continue meeting on the third Friday of the month for regular Board meetings in 2015 with exceptions in November and December. They will meet on November 5, 2015 at the KCA Conference in Louisville, and on December 11, 2015.
