## **CALL TO ORDER**

Dr. Martin Wesley, board chair, called the meeting to order at 10:11 a.m.

# **MINUTES**

Mark Hamm made a motion to approve the minutes from the May 19, 2017 meeting. Motion, seconded by Summer Watson, carried.

# **MONTHLY FINANCIAL REPORT**

The financial statement for the month ending May 31, 2017 was presented to the Board for review. No further action was required.

## **REPORT FROM O&P**

Robin Vick, Section Supervisor, went over the LPCC-S status update options in the back office. The board asked that a seal be created for the "S" designation to be added to a licensee's license certificate. Ms. Vick is in discussion with the system programmers for LPCA supervisors to be added to public view.

#### **NEW BUSINESS**

Mr. Hamm motioned to recess for lunch at 11:58 am. Motion, seconded by Dr. Bratton, carried.

Brian O'Rear motioned to come out of recess at 1:12 pm. Motion, seconded by Dr. Bratton, carried.

Dr. Wesley recognized the board's legal counsel for the work he's accomplished through the LPC Board. Dr. Bratton motioned to provide a plaque for Brian Judy's service to the board. Motion, seconded by Mr. Hamm, carried.

The board's interpretation of 201 KAR 36:065 (1) (d) is that the graduate level course in supervision has to be exclusively in supervision. Mr. Hamm motioned to amend 201 KAR 36:065 Section 1 (3) to include the three hour graduate level course in supervision: delete under section 1 (3) (a) 4 that Kentucky laws must be included and amend section 1 (3) (b) to clarify that the board approved supervision training course must be conducted by an LPCC. Approve the LPCC-S application form: Amend 201 KAR 36:065 to reflect that the graduate level supervision course shall be exclusively on supervision. Motion, seconded by Dr. Bratton, carried.

Dr. Pemberton made a motion that the chair, or chair's designee, will approve final verbiage as suggested by LRC on "exclusivity on supervision". Motion, seconded by Mr. Griffith, carried.

The board discussed non-expiring LPCC supervisors and asked that supervisors without an expiration date in the back office be required to submit an LPCC-S designation form.

The board discussed the FBI Approved Channelers and what other options the board had to fill the timeframe gap for applicants waiting on the results from their FBI Background Check. Charles Pemberton motioned that 201 KAR 36:070 be amended to accept an affidavit during pendency of completion of FBI background check in instances that the applicant has not been convicted of a misdemeanor within the last 5 years or felony and proof that background checks have been submitted. The chair will approve final affidavit and verbiage of amended 36:070. Motion, seconded by Ms. Watson, carried.

The board reviewed email correspondence from Caroline Cornett. Without an application to review, the board is unable to determine the situation. Therefore, she will need to submit an application for board review. No further action required.

The board discussed the required LPCC-S 15-hour CEU training. The board's interpretation is that any 15-hour supervision course being offered has to be board reviewed and approved to count towards the licensee adding the "S" designation. No further action required.
